## Dear Friends,

Following a meeting I had with Janet, Matt and Jules on 4<sup>th</sup> November and subsequent conversations with Sheila and Jules I am writing now to share with you an update on the ongoing situation at St Lawrence's which will then be shared at tonight's meeting of the PCC. I suggest that Matt reads this statement at the meeting.

At the Standing Committee on the 5<sup>th</sup> March it was agreed that Jules and Sheila would enter into a mediation process that would be facilitated by the diocese. None of us could have known that the first lockdown was so imminent and nor that it would so significantly delay that process. However, it did eventually begin, facilitated by independent and experienced mediators. However, I am sorry to say that the mediation process has failed and is no longer continuing.

Following that, I have spoken to Sheila and to Jules and those conversations will be ongoing with both of them as well as with the Standing Committee. Sheila has now decided, after a great deal of prayerful reflection and following a conversation with me, that for her own wellbeing she can no longer remain at St Lawrence's and so is stepping back completely from any ministry there. I will continue in conversation with her about her ongoing ministry and what the future looks like. This is clearly a difficult decision for Sheila to have arrived at and I know that everyone at St Lawrence's will continue to pray for her. I will also continue in conversation with Jules as to how he takes forward the ministry which is entrusted to him at St Lawrence's. I ask that you will continue to pray for him also.

I know that we all share a deep sense of sadness of how things are currently at St Lawrence's and I continue to pray for you all, as together with Archdeacon David we seek together to find a good way forward.

The contents of this update are to made public following the meeting of the PCC.

May God bless and guide us in all of this.
